It was unanimously agreed that the above norms shall be followed from the academic year 2018-19. **A supervisor shall be allowed to guide not more than five M.Phil., candidates at a time for this academic year 2017-18 only.** Only the predetermined number of students (20 for Science excluding Maths and 25 for Arts & Maths departments) may be admitted to M.Phil., Programme.
