

 - ii) In the department of Environmental Science, Food Science and technology and Pharmaceutical on 22.09.2006 as these was barely any students, the Thiruvalluvar University Syndicate decided to cancel these above said courses and convert Plant Science Technology into Zoological technology and Chemistry departments into Applied Chemistry.
 - iii) 09.03.2007 and 07.05.2007 during the Financial meeting held in the departments of Environmental Science/ Food Science/ pharmaceutical, Plant Science Technology, PG English.
3. The Thiruvalluvar University Registrar was requested to convert the above said four departments into Tamil, Mathematics , Plant Technology, PG English and is requested 16 teaching course to be converted to the same.
4. The Conception of the Registrar, Thiruvalluvar University was inspected by the Government. The above mentioned teaching post vacancies has been sanctioned by the Government.
