With reference to the Govt. letter cited above, I am by direction to inform that in view of the rural local body elections 2019 to franchise their votes by the students in Tamil Nadu and also in view of the impending festivities viz. Christmas on 25.12.2019 and the New Year celebration on 01.01.2020, the Government of Tamil Nadu has declared four (4) additional holidays (**23.12.2019, 24.12.2019, 26.12.2019 and 31.12.2019**) for the students of the University / Colleges. Accordingly, these institutions will be closed for the students from **21.12.2019 to 01.01.2020** and to re-open the University / Colleges on **02.01.2020**.

Hence, the Government has requested to compensate the above four holidays by conducting classes on Saturdays / other holidays. (A copy of the Government letter is enclosed for reference)
