# <u>Applying for M.Phil.Degree Programme in University Departments / Affiliated Colleges / Approved Institutions.</u>

- The application fee of Rs.500/- (Rs.200/- for SC/ST) should be remitted through NEFT/RTGS mode in the Indian Overseas Bank IFSC Code: IOBA0002484 MICR Code: 632020014 Account number: 24840100000001 and the original bank challan with UTR number should be enclosed with the application form.
- 2. The minimum marks for admission to Full-Time M.Phil. Degree course shall be 50% for the candidates who have qualified for the Master's Degree prior to 01.01.1991 and 55% for the candidates who have qualified for the Master's Degree on or after 01.01.1991. There is no provision for rounding off of 54.5% and above marks to 55%. For candidates belonging to SC/ST Community, who have qualified for a Master's Degree on or after 01.01.1991, a concession of 5% of marks will be given in the minimum eligibility marks prescribed.
- 3. Self attested copies of mark statements of the qualifying examination should be sent along with the filled-in application form.
- 4. Common Entrance Examination Mark Result should be enclosed.
- 5. The candidates who have passed their qualifying examination from other Universities shall obtain the **Eligibility Certificate** from Thiruvalluvar University and submit the same at the time of admission.
- 6. Application form for obtaining Eligibility certificate can be downloaded from the University website <a href="www.tvu.edu.in">www.tvu.edu.in</a> (Under Admission -> Download Applications) and candidates are directed to contact the Admission section of this University.
- 7. Criteria for the Selection of candidates towards M. Phil admission will emphasize equal weightage on percentage of PG marks obtained (50%) and from entrance exam (50%).
- 8. University is not responsible for any postal delay or loss in transit.
- 9. Numbers of seats are limited to each department and the selections are purely based on the Reservation Policy prescribed by the Govt. of Tamil Nadu.
