2. Should have signed an MoU with two Universities.
3. Should have executed similar programmes under Tamil Nadu State Council of Higher Education.
4. Must be an EduTech company registered in RoC Tamil Nadu.
5. Should have trained minimum 1000 students in the last 5 years on Offline Mode.
6. Should have trained at least 50 to 100 students in **UG** Degree in B.Voc in Immersive Technology.

7. Should be an authorized game engine OEM in India.
8. Should have obtained course mapping approval for minimum two courses from Sector SkillCouncil related to in B. Voc in Immersive Technology.
9. Should be registered entity with MSME.
10. Should be an active NSDC Partner.
11. Should have signed at least five LoI (Letter of Intent) with relevant industry partners for the placements.
12. Should have successfully placed minimum 70% of the students completed the degree programme.
13. Should have provided internships for a period of 30 to 45 days to the students who have undergone the degree in B.Voc Immersive Technology.
